Wood Street Commons currently has a limited number of vacant Section 8 rooms designated for anyone with a documented disability and we need applicants.

#### **Who Should Apply?**

- ✓ ANYONE with a documented disability.
- ✓ ANYONE who is experiencing homelessness.

#### **Benefits of Section 8:**

- ✓ PBV Disability Unit- After resident completes a 1-year lease term they can use voucher for other housing.

#### **Apply Today:**

- ✓ **Pick up application packet or request packet be emailed.**
- ✓ **Print application packet at [www.pghsrohousing.com](http://www.pghsrohousing.com)**
- ✓ Gather the required documents.

If you apply, qualify, and move into an assigned Section 8 PBV Disability room, you will receive **1 month of FREE Rent (monthly rent discount is equal to residents' monthly rental portion as determined by the HACP)**

Must submit completed application for processing by May 26th, 2025. All required documentation must be submitted with application for processing to qualify.

*\*Offer only applies to Section 8 PBV Disability Units, 1-month free rent will be applied at move-in based upon rent amount on your new lease as determined by the Housing Authority. Offer valid for new applications April through May 20th only.*

SRO units: Single Room Occupancy. 28 Sleeping rooms per floor with 5 individual restrooms on floor. Male and Female floors.

- 90 Paid Room (must have steady source of income)
- 28 Project base units with homeless preference – non portable voucher
- 65 units with disability preference - These units offer a portable voucher after the resident completes a year's lease.
- About 6 weeks processing time – This is depending on the applicant providing ALL required documents and applicants follow up when necessary. Income must be within 60 days of application (this can cause delays in processing)

FREE laundry, FREE Wi-Fi, NO security deposit.
